Testing & Quarantine measures for international attendees

1 Arrange your Travel Visa

Some countries are eligible for the Korea Electronic Travel Authorization (K-ETA) visa waiver. Read more [here](#).

2 Register your vaccination history on the Q-CODE website

From 8 June 2022, you are exempt from quarantine regardless of vaccination if you hold a PCR negative test result tested within 48 hours OR a negative RAT test within 24 hours prior to departure.

You do this by registering your vaccination history in the Korean government's Q-CODE system:

We recommend using your mobile or tablet to access Q-CODE here

You can register early and save your progress. Please be ready to provide:

- ✓ Valid passport information
- ✓ Valid flight information
- ✓ Valid accommodation address
- ✓ COVID-19 vaccination certificate
- ✓ A negative COVID-19 test result (see next step)

3 Negative pre-departure tests to enter Korea

A **supervised RAT test** within 24 hours or a **PCR test** within 48 hours before your departure date are valid.

E.g., if your flight is at 14:00 on June 15, you must submit the PCR test result taken after 00:01 on June 13 or supervised RAT result taken after 00:01 on June 14.

※ A supervised negative COVID-19 Rapid Antigen Test (RAT) result will be additionally accepted from May 23, 2022.

Note that all forms of self-administered tests are **NOT** valid

4 Enter your test results in Q-CODE

The test information must be written in English or Korean.

Receive your QR code from Q-CODE

You are required to show this to Korean immigration officials upon entry.

5 Reserve your arrival PCR test

To avoid queues, you can reserve your test online at [Safe2Go](#).

6 Arrive at Incheon International Airport, Seoul

7 Complete PCR test at the airport

Operating hours: 07:00 ~ 21:00
Please kindly note that tests are at attendees' expense. (₩80,000, or approx. USD \$65)

8 Transit to your hotel By limousine bus or taxi

Your results will be provided via email 6 hours after completing your PCR test. We kindly ask you remain in your room until then.

E.g., Test Time	Checking the results
15:00~17:30	After 21:00 (same day)
18:00~20:45	After 8:00 (next day)

7 Incomplete PCR test at the airport

Within 3 days, you **must** complete PCR test at medical center nearby your hotel.

※ RAT test is **NOT** valid.
